


Welcome New Directors to the Board

- Terms for the Incoming Directors begin at the conclusion of Meetings
- Roughly ½ of Directors are nominated each year, forming two "classes" of Directors, so that at least ½ of the Directors have previous service on the Board for continuity
- Terms run 2 Years (again they alternate for each class)
- A Board Member may be nominated to serve up to 3 consecutive terms
